# Reason for the Charity

Friends of Tremanna raises funds to help Care Experienced young people who live in or have lived in Tremanna Children's Home, based in Slamannan near Falkirk.

The Charity raises funds to help fill the gap between the limited statutory local council provision and that which most parents and carers provide for their children. The Charity also supports young people to thrive once they have left care. Funds are used to provide items, such as, birthday celebrations, days out, holidays, work experience and employment support items (travel costs, clothes, tools, etc.), education and training support, development of life skills and emergency living costs.

Friends of Tremanna has no employees, all involved are unpaid volunteers. As a result, administration costs are very low and the vast majority of funds are spent directly on beneficiaries.

#### Structure, Governance and Management

#### Constitution

The Charity is a Scottish Charitable Incorporated Organisation (SCIO) and our governing document is a "Constitution". It was formed upon registration with the Office of the Scottish Charity Regulator (OSCR) on 8th March 2017. It is a single tier structure where the trustee are the members of the Charity.

The Trustees meet a minimum of four times per year.

### **Appointment of Trustees**

The constitution states that there must be a minimum of three trustees and a maximum of ten. Any person wishing to become a trustee must sign a written application. The application would then be considered by the Trustees at the next Board meeting. The Board may, at its discretion, refuse to admit any person to trusteeship.

All trustees retire at each Annual General Meeting, but may be re-elected at the same meeting.

## Management

The Trustees are the managers of the Charity. A meeting of the Trustees, at which there is an appropriate quorum, may exercise all the powers of the Charity in respect of fundraising and expenditure.

#### **Objectives and Activities**

# **Charitable Purpose**

Friends of Tremanna raises funds to help Care Experienced young people who live in or have lived in Tremanna Children's Home, based in Slamannan near Falkirk.

The key objectives are -

To advance education; through the provision and funding of training opportunities for young people who live or have been resident in Tremanna.

To advance health; through maintaining and sustaining relationships with the young people who have been looked after within Tremanna and including them in social gatherings, activities and outings that will improve their mental health and meet the wellbeing indicators for looked after young people.

To provide recreational facilities, or organise recreational activities, with the object of improving the conditions of life of the persons for whom the facilities or activities are primarily intended; by planned, managed and supervised day trips we aim to improve participants social, communication and timekeeping skills.

#### **Activities**

The charity organised a very successful Winter Ball for residents, former residents and their families in November. The Ball was the idea of a former resident of Tremanna who stated that many young people in care missed out on their schools' prom. The Ball was the social highlight of the year.



The young people experienced the full "prom-night glitz and glamour". They arrived by limousines and a piper welcomed them onto the red carpet that led into the Macdonald Inchyra Hotel. There was food, dancing and speeches – memories of their time in Tremanna, from both the young people and the care team.

A very emotional and very enjoyable night for both the young people and the care team.

The Ball was very generously supported by local companies who supplied the following for free -

- Slaters Menswear (Stirling) provided the boys with smart fashionable suits, shirts, shoes and ties of their choice to keep!
- Olivia Cameron Bridal supplied the girls with beautiful dresses of their own choice
- DJC Makeup Artists did the girls hair and make-up.
- Highland Harmony Entertainment provided the piper, the music and an excellent live singer.

Discounted services were also received from Pink Limo, Jennifer Morrison (corsages) and Macdonald Inchyra Hotel.

The Winter Ball received excellent publicity both before the event and afterwards from the Falkirk Herald newspaper.

The charity also facilitated the continued operation of the social activity Arts and Crafts Club.

Support was also provided to beneficiaries for -

- birthday and Christmas celebrations.
- · food, energy and phone costs.
- · clothing and haircuts.
- household equipment.
- · driving lessons.

#### **Achievements and Performance**

The charity has been able to respond quickly to the basic living needs of nine former residents over the year mostly on more than one occasion. This support was well received and is a key reason for the formation of the charity.

We also enabled birthday and Christmas celebrations and social events for fifteen former residents in addition to the Winter Ball and the Arts and Crafts meetings mentioned above.

One former resident was helped with driving lessons costs.

The charity has been very successful in raising funds from both grants and donations from local and national sources. The grants are for direct expenditure on beneficiaries and meet the key purposes of the charity.

Friends of Tremanna has seen this year as one where we have come together to celebrate achievements, new arrivals and work together on exiting projects.

Laura, who lived with us in Tremanna from the age of 11 and is now 24, saw the arrival in May 2019 of a beautiful baby girl – Lily. Laura and Lily still come back to visit Tremanna and we enjoy seeing them both.

The weekly Arts and Crafts Club continued to operate and we were successful in obtaining funding for a "Candy Cart" to sell crafts at events. The Arts and Crafts Club is not just about making things, it's another opportunity for a get together on a weekly basis, to chat about what's going on and to socialise.

The Arts and Crafts Club was commissioned to make Christmas cards and bandanas by a local business - Dave's Dugs Dog Walking and Home Boarding. A perk of this was a visit to Tremanna of the dogs and a mini photo shoot took place with them. There's a video on the Friends of Tremanna Facebook page which shows us meeting our "Furry Friends of Tremanna" - so have a look!

The following case study illustrates some of the work of Friends of Tremanna.

#### Laura's Story

I was living in Tremanna for many years before I made the transition from Tremanna to TMOR (moving on flat) where I was still able to get lots of support from the Tremanna staff team if and when it was needed. I then made the transition into my own first house where I began to go off the rails a bit and ended up leaving my tenancy.

However, I had the Tremanna family behind me, supporting me, not giving up as I pushed them away. I managed to find the right path to be on for me and my amazing partner and our beautiful daughter.

The Tremanna staff team have been so supportive. I sometimes wonder where I'd be today if I didn't have their help? Their support is amazing in every way, they don't judge you for your past, look down at you etc. They are very understanding and take the time to listen even though I am no longer residing in Tremanna.

The support they all provided to me when I was pregnant with my daughter, Lily, was out of this world. They helped me prepare for Lily coming by making sure I had the items etc. I needed. For example, Adele collected a cot, bean bag, clothes etc. for Lily and dropped them off at my house. They helped me prepare my own house for little miss coming.

Pauline and Carol provided support through Friends of Tremanna to get me suitable flooring for parts of my flat as well as blinds for my home. Staff helped me to clean and make it into a home not only for me but for my baby Lily, as well.

Since I have had Lily the support is incredible. We have been picked up and taken to Tremanna for our dinner and returned home after a few hours. Being able to take Lily to the Tremanna home and meet the people that made my life worth it, giving me a meaning, the best life they could since taking me into the Tremanna family, touches my heart every single time. I am so proud and always will be of being a part of Tremanna and I will always make sure that Lily knows them and knows the extent these lovely women and men go to everyday for us.

Friends of Tremanna helped us in so many ways whether it be from flooring, blinds, wee bits for Lily and massively helping me get back into work by supplying suitable work clothes. They don't get enough credit but they sure do need to be praised for all the amazing work and support they give the young people, in and out of Tremanna, and our gorgeous children.

#### **Financial Review**

The charity received grants of £4,925 and donations of £663 in the year. We spent £4,438 in the year, £4,303 (97%) directly on beneficiaries. The only expenditure that was not directly on beneficiaries was entity insurance and bank charges of £135 in total.

#### **Reserves Policy**

The charity does not have employees and has very low levels of on-going costs. As a result, the Trustees propose to keep reserves very low. A sum of circa £300 will be retained to meet emergency living costs of beneficiaries.

#### Plans for the next year

The Trustees will continue to try to raise funds from both grants and donations - this will be an ongoing activity which is led by a sub-group of Trustees.

We will continue to respond to the needs of residents and former residents and take a proactive approach to organising social events for beneficiaries.

# Independent Examiner's Report to the Trustees of Friends of Tremanna SCIO SC047225
